GENERAL CONDITIONS OF SALE

Rental conditions:

The reservation is nominative and made on a strictly personal basis. In no case can it be transferred.

The reservation will be effective as soon as we receive the completed and signed reservation document, accompanied by a down payment of 30% of the rental amount. Concerning the accommodations, the campsite requests administration fees of an amount of €17; 10 euros for the pitches in the high season.

Campite pitch:

Up to 6 people max. authorized by pitch. In July and in August, the time of arrival must be between 2pm and 8pm and the pitch has to be vacated before 12am on the day of departure.

For Premium pitches, a deposit cheque for €100 will be required.

Each stay must be paid before or on your arrival at the latest.

Rental accommodation:

The accommodation is available starting from 3pm (an inventory will be taken on the day of arrival) and should be left within 10am of the check out day (an outgoing inventory will be taken on between 8am and 10am).

A deposit cheque (200€) will be required on the day of your arrival for property damage and to ensure that the accommodation is perfectly clean at the end of your stay. Concerning the Tipi and the Bivouac, the deposit cheque amount to €100.

The paiement has to be made on the day of your arrival, in cash or by holiday cheques (and at least 15 days before your arrival if you chose to pay by bank cheque).

Pets are forbidden inside the accommodations as well as on the corresponding pitches.

It is forbidden to smoke inside the accommodations and to throw cigarette butts on the parcels.

Cancellation:

Any cancellation of stay has to be made in writing and will come into effect from the time we receive the mail.

For cancellation reported more than 30 days before arriving, the amount of the deposit as well as administration fees will be retained by the campsite. If a cancellation is reported less than 30 days before arriving, or if you do not show up, the full amount of the stay may be required.

Without any notification on your behalf, the accommodation or the pitch will be made available again for sale 24 hours after the arrival date specified in the contract and the deposits will be retained by the campsite (the full amount of the stay may be required).

Only a cancellation insurance (facultative) allows you to obtain reimbursement of the sums paid. We thus advise you to take out, at the time of the booking, an insurance contract of your choice, in order for you to be covered against the consequences of a cancellation or interruption of your stay.

Extract from the internal regulations:

On your arrival, please take note of the campsite's internal regulations. They are displayed at the reception. A civil liability insurance is compulsory during your stay.

Inside the campsite, the speed of vehicles is strictly limited to 10 km/h and there can be no driving between 10.30 pm and 7 am.

Barbecues (unless they are electric or gas barbecues) are forbidden outside the area delimited for this purpose.

Dogs (apart from dogs of 1st and 2nd category) and cats are admitted in the campsite, but they are forbidden inside the accommodations. A vaccination certificate must be presented on your arrival. Dogs must be kept on leashes and must be under the direct control of their owners at all times.

Further information:

For safety reasons, any visitor from outside the campsite has to register at the reception before being authorized to enter the campsite. Visitors have to pay a fee and their presence is under the responsibility of the resident they visit.

It is recalled that children are under the supervision of their parents or of adults who are responsible for them.
